CIVIL CASES

General Civil- Superior and State Court \$212.00

Plus applicable service fees. *ALL cases except: 1) Family violence; 2) abandoned motor vehicle actions; and 3) Incoming transfers. See below for additional sums in condemnation and bond validation cases.*

Exceptions: OCGA §15-21A-6 ;OCGA §15-21A-6.1 and OCGA §15-21A-6.2
State, municipalities, counties, political subdivisions or agencies are not required to pay the \$15.00 indigent defense services and \$125.00 Judicial Operations Fund fees.

Filing Fee Required:

Motions or petitions requesting an order filed 30 or more days after judgment or dismissal require a new action filing cost. Exception: contempt for child support or alimony, No Fee.
