### Access to Land and Court Records is now at Your Fingertips

Historically, a trip to the Office of the Clerk of Courts of Liberty County was required in order to access or get a copy of your land and court records. Although I enjoy immensely visiting with patrons of the office, I now provide for your convenience online access to most land and countless superior, state, and magistrate court records, making them accessible to you around the clock on your PC, iPad or iPhone. Juvenile court records and court records that are sealed pursuant to a court order are fundamentally the only records to which electronic access is not provided.

Court records and volumes of other court-related information can be accessed on the office's website at [www.libertyco.com](http://www.libertyco.com). Online access is provided to civil and criminal case docket information, with access to actual images of documents that contain confidential personal information (such as birthdates, Social Security numbers, and bank account and credit card numbers) provided only to court officials and agencies as a safeguard for protecting litigants from potential fraud and privacy issues. 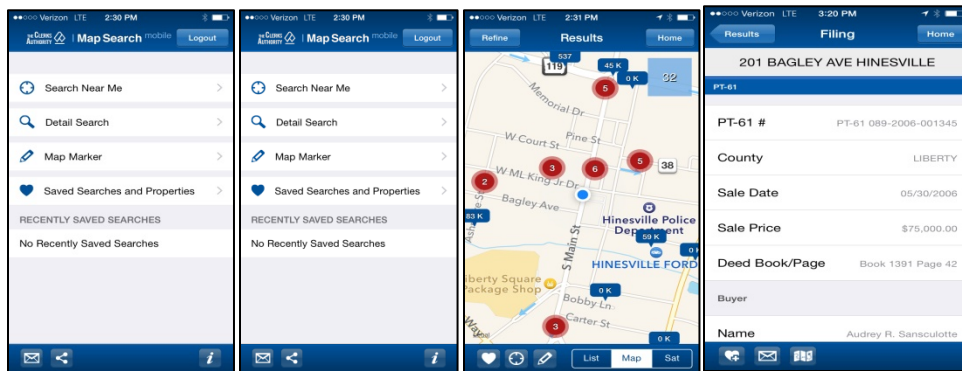
IPad and iPhone users can access court dockets and schedules through *JusticePath*, an IOS application available at Apple's App Store. The application enables users to view daily superior, state, and juvenile court schedules, the courtroom and judge to which each court case is assigned, and a list of all cases (other than juvenile) scheduled for hearings and/or trials that day. Search for and download the JusticePath application and then bookmark Liberty County (Georgia) Clerk of Court and Liberty County GA Court Dockets.



Also, by and through services provided by the Georgia Superior Court Clerk, the office provides a mobile application, *MapSearch*, an invaluable tool that provides iPad and iPhone users immediate, in-the-field access to real estate property information statewide—including GIS-enabled location of property, access to real estate sales, property tax (PT-61) data, and actual images of warranty and security deeds conveyancing the property. With the touch of a fingertip, almost anything about a specific parcel or tract of land that has been conveyed since 1991 (and, in some counties, as far back as the 1700s) can be accessed on a personal computer or portable electronic device.

To use the mobile application, users must subscribe to the authority's Premium Search package, which facilitates both online and mobile access to the authority's statewide real estate and personal property information system.
