
# ORDER FOR FILING AND PUBLICATION OF GRAND JURY PRESENTMENTS

#### **GRAND JURY PRESENTMENTS**

September Term, 2013

We, the Liberty County Grand Jury for the September 2013 term convened on September 9, 2013 at the Liberty County Justice Center. After having been duly selected and impaneled, the body was sworn in by Judge Paul Rose. At which time Judge Rose instructed the members of the Grand Jury in its duties and responsibilities. The jury consisted of 22 members whose names are contained in EXHIBIT A hereto.

On September 10, 11, and 12, November 7, and December 3 and 4, 2013, the Grand Jury heard presentation of a number of indictments by the Atlantic Judicial Circuit District Attorney's Office. The Grand Jury returned True Bills on a number of the indictments.

During the month of September 2013, the Grand Jury met to discuss inspection committees and to make a decision whether to retain or appoint new members to the Board of Equalization – the decision was made to retain the current members. When we were reconvened in the month of December, it was stated that one of the members was unable to perform the duties required for the Board of Equalization, and the jury voted that Mr. Donald L. Snelsire would fill the vacant position on the board.

Seven members of the Grand Jury, including the foreman, conducted inspections of the Liberty County Jail on Friday, September 13, 2013. The day to day operations of the jail were explained to us and we were taken on a guided tour throughout the jail to the various areas and departments. We were introduced to staff and taken to the tower to view the area where the inmates are housed. The Grand Jurors did not detect any deficiencies with the personnel or the facilities and all agreed that the jail is being maintained in excellent condition.

On November 7, 2013, the Grand Jury was called in to receive criminal presentments from the district attorney in a special case, true bills were returned on all counts of the indictments regarding that case.
