We, the Liberty County Grand Jury for the February 2013 term convened on February 11, 2013 at the Liberty County Courthouse. After having been duly selected and impaneled, the members of the jury were sworn in by Judge David Cavender. Judge Cavender instructed the members of the Grand Jury in their duties and responsibilities. The jury consisted of 27 members whose names can be found in Exhibit A.

On February 11, 2013 and May 22, 2013 the Grand Jury heard presentments on 184 indictments by the Atlantic Judicial Circuit District Attorney's Office. The Grand Jury returned True Bills on 172 of the indictments and No Bill on 12 of the indictments.

There were no required inspections of county offices and therefore we the Grand Jury elected not to conduct any inspections or examinations of county offices or public buildings during this term. Therefore there are no special presentments.
