Grand Jury Presentments
February Term 2016

We, the Liberty County Grand Jury for the February 2016 term convened on February 8, 2016 at the Liberty County Courthouse. After having been duly selected and impaneled, the body was sworn in by Judge Paul Rose. At this time, Judge Rose instructed the members of the Grand Jury in the duties and responsibilities expected to be carried out during the term of duty. The jury consisted of twenty-three members whose names are contained in "Exhibit A" attached hereto.

On February 9, 2016, the Grand Jury heard presentations of a number of indictments by the Atlantic Judicial Circuit District Attorney's Office. On that day the Grand Jury returned 42 true bills. In addition; John W. Gaddy and Donald Snelshire were appointed as Alternate members six and eight, respectively, of the Liberty County Board of Equalization.

On June 8, 2016, jury members returned to continue their assigned task and returned 20 true bills and one no bill.

On August 24, 2016, at 9:00 AM the Grand Jury Foreman and two Grand Jurors (Robin Grilley and Edward Oglesby) met for an inspection of the Liberty County School Superintendent's office. We were provided a tour of the entire office by Dr. Valya S. Lee. Dr. Lee was very open and helpful and was very informative in helping us to understand the internal structure and focus of the office. We found each work area to be of efficient and professional design and to be very neat and clean. The employees that we met were very presentable and polite and were most happy to contribute to Dr. Lee's tour. We found at the time of our inspection that the hvac system was down in most of the office and that it had been a recurring problem since the building had been constructed. Dr. Lee had already pursued a remedy to the deficient hvac unit and a replacement was on order.

In summary; our inspection did not determine that any negative issues or conditions were apparent in the superintendent's office and no need for improvement was noted.
