


Inspection of Sherriff's Office

On May 8, 2018 nine members of the Grand Jury inspected the Sherriff's Office. During the inspection the office was clean and presentable to the public. This office handles various aspects of the Hinesville police force. The sheriff's office serves papers, transports citizens, patrols the streets, files firearm fingerprints, collects vehicle crash reports, registers sex offenders, etc. There are approximately 65 employees at the jail. The jail spends about \$4,000 per week on meals for the inmates.

Chief Deputy Jon Long was our point of contact for the tour. He stated that the annual budget process was coming up in July 2018. Some of the items on the budget were new police cars, new record management software, updates to the vendor software, and a drone to help with manhunts. Officer Sikes stated that patrol cars are a major expense because they wear our fast. Although the costs have somewhat stabilized since transitioning the vehicle fleet to Dodge vs. Ford. From a budget perspective, payroll is another major expense for the department. All employees did receive a merit increase in Jan 2018. Health insurance rates are steadily increasing year after year. Overall the annual budget for the Sherriff's Office was approximately \$10 million dollars.
