

After being selected on February 11, 2019 and impaneled, the panel was sworn in by the Honorable D. Jay Stewart. Then, the members of the Grand Jury were instructed of their duties and responsibilities that were expected to be carried out during the term of duty. The Grand Jury selected consisted of Twenty-three members.

On February 11-12, 2019 the Grand Jury heard presentations given by the district Attorney, Liberty County Sherriff's office, City of Hinesville Police office and Fort Stewart Investigators. The Grand Jury returned True Bills as well as No Bills on a number of indictments. The Grand Jurors reviewed the Clerk of Courts financial statements, discussed Bailiff's pay and uniform allowance.


