Read the Calendar Carefully. You **MUST** appear on the day for Rule 20 Calendar Call. These dates are before your trial.


NOTICE TO BONDSMEN:

Jay Stewart on Wednesday, March 11, 2026, at 9:00 A.M. and jury selection will be held on Thursday, March 26, 2026, at 9:00 A.M. at the Liberty County Justice Center. Attorneys and Defendants in all cases listed on this calendar are **REQUIRED** to be present on both dates.

Judge D. Jay Stewart's cases will be tried on March 30, 31 and April 1, 2, 6, 23, 28, and 29, 2026.
