Read the Calendar Carefully. You **MUST** appear on the day for Rule 20 Calendar Call. These dates are before your trial.


NOTICE TO BONDSMEN:

A calendar call under Rule 20 U.S.C.R. will be held before the Honorable Charles P. Rose, Jr. on Wednesday, September 3, 2025, at 9:00 A.M. and jury selection will be held on Thursday, September 25, 2025, at 9:00 A.M. at the Liberty County Justice Center. Attorneys and Defendants in all cases listed on this calendar are **REQUIRED** to be present on both dates.

Judge Charles P. Rose, Jr.'s cases will be tried on September 30, and October 1, 2, 3, 10, and 17, 2025.
